**NOTICE IS HEREBY GIVEN** pursuant to Arkansas Election Law, Arkansas Code Annotated §7-5-202, all qualified electors are notified that the 2026 Preferential Primary, Nonpartisan Judicial, and Annual School Board Election will be held on **Tuesday, March 3, 2026**. The election will submit to a vote of the electorate all candidates by name and office and all other measures and questions required by law to be submitted to the electors. The polls will be open 7:30 a.m. until 7:30 pm.

**EMERGENCY CLOSURE FOR EARLY VOTING**

In the case of a severe weather event or other emergency during the time period of Early Voting (February 17, 2026 and March 30, 2026) the only locations that will be kept open will be St. Elizabeth Parish Center, 232 Passion Play Rd., Eureka Springs and Berryville United Methodist Church, 400 Eureka Ave., Berryville. This decision will be made, based on recommendations from the Carroll County Judge's Office, Carroll County Emergency Management and Carroll County Sheriff's office to the Carroll County Election Commission. Ark. Code Annotated § 7-5-418 (h)(1) Except as provided in subdivision (h)(3) of this section, the county board of election commissioners may call an emergency meeting held in person or by electronic means to close one (1) or more early vote locations for one (1) or more days due to inclement weather.

Absentee voting will be conducted through the Carroll County Clerk's Office, 210 W. Church Ave., Berryville, AR 72616. The telephone number is 870-423-2022.

The deadline for the County Clerk to receive absentee ballot applications by mail, fax, or e-mail for Preferential Primary is February 24, 2026.

The deadline for County Clerk to receive absentee ballot applications in person from the voter, designated bearer, or administrator is February 27, 2026, no later than 4:30 p.m.

Absentee ballots will be processed and canvassed beginning 10:00 a.m. on February 24, and February 27, and 3:00 pm on March 3, 2026.

Early voting and absentee votes will be counted at 7:30 p.m. on March 3, 2026, at the Carroll County Courthouse, 210 W. Church Ave., Berryville, AR 72616.

In accordance with the requirements of Ark. Code Ann. § 7-5-202(b)(2)(A), a notice of election officials will be posted as of February 8, 2026, and remain posted until March 13, 2026, at the County Clerk's Office in the Eastern and Western District Courthouses. Ark. Code Ann. § 7-5-202

\*(a)(2)(B) Another person makes an objection to his or her service to the County Board of Election Commissioners within seven (7) calendar days after posting the list of officials. Grievances can be filed by submitting a written objection to the County Clerk's Office. An objection that an official is a spouse of a county commissioner, a county party chair, or a spouse of a county party chair must be within 7 days of February 8<sup>th</sup>. An objection that an official is married to a candidate or related to a candidate within two degrees of blood relations must be filed within 10 days of February 8<sup>th</sup>.

## Berryville School District No. 27 of Carroll County

### 42.2 Mill School Tax

The total tax rate proposed above includes the uniform rate of tax (the "Statewide Uniform Rate") to be collected on all taxable property in the State and remitted to the State Treasurer pursuant to Amendment No. 74 to the Arkansas Constitution to be used solely for maintenance and operation of schools in the State. As provided in Amendment No. 74, the Statewide Uniform Rate replaces a portion of the existing rate of tax levied by this School District and available for maintenance and operations of schools in this District. The total proposed school tax levy of 42.2 mills includes 25.0 mills specifically voted for general maintenance and operation and 17.2 mills voted for debt service previously voted as a continuing levy pledged for the retirement of existing bonded indebtedness. The surplus revenues produced each year by debt service millage may be used by the District for other school purposes. The total proposed school tax levy of 42.2 mills represents the same rate presently being collected.

## Eureka Springs School Dist. No. 21 of Carroll County

### 35.80 Mill School Tax

The total tax rate proposed above includes the uniform rate of tax (the "Statewide Uniform Rate") to be collected on all taxable property in the State and remitted to the State Treasurer pursuant to Amendment No. 74 to the Arkansas Constitution to be used solely for maintenance and operation of schools in the State. As provided in Amendment No. 74, the Statewide Uniform Rate replaces a portion of the existing rate of tax levied by this School District and available for maintenance and operation of schools in this District. The total proposed school tax levy of 35.80 mills includes 25.0 mills specifically voted for general maintenance and operation and 10.80 mills voted for debt service previously voted as a continuing levy pledged for the retirement of existing bonded indebtedness. The surplus revenues produced each year by debt service millage may be used by the District for other school purposes. The total proposed school tax levy of 35.80 mills represents the same rate presently being collected.

## Green Forest School Dist. No. 32 of Carroll County

### 42.0 Mill School Tax

This represents no change from the previous year. The total tax levy proposed above includes 25 mills for maintenance and operation of schools, 0 dedicated maintenance and operation mills dedicated for 0 purposes, and 17 mills for debt service previously voted as a continuing debt service tax pledged for the retirement of existing bonded indebtedness. The district may use surplus revenues produced each year by debt service millage for other purposes.

## Alpena School Dist. No. 5 of Boone / Carroll Co.

### 33.6 MILL SCHOOL TAX:

The total tax rate proposed above includes the uniform rate of tax (the "Statewide Uniform Rate") to be collected on all taxable property in the State and remitted to the State Treasurer pursuant to Amendment No. 74 to the Arkansas Constitution to be used solely for maintenance and operation of schools in the state. As provided in Amendment No. 74, the Statewide Uniform Rate replaces a portion of the existing rate of tax levied by this School District and available for maintenance and operation of schools in the District. The total tax levy of 33.6 mills includes 25.6 mills specifically voted for general maintenance and operation and 8.0 mills voted for debt service previously voted as a continuing levy pledged for the retirement of

existing bonded indebtedness. The surplus revenues produced each year by debt service millage may be used by the District for other school purposes. The total proposed school tax levy of 33.6 represents the same rate presently being collected.

**Jasper School Dist.1 of Newton / Carroll Co.**

**36.8 Mill School Tax**

The total tax rate proposed above includes the uniform rate of tax (the "Statewide Uniform Rate") to be collected on all taxable property in the State and remitted to the State Treasurer pursuant to Amendment No. 74 to the Arkansas Constitution to be used solely for maintenance and operation of schools in the State. As provided in Amendment No. 74, the Statewide Uniform Rate replaces a portion of the existing rate of tax levied by this School District and available for maintenance and operation of schools in this District. The total proposed school tax levy of 36.8 mills includes 25.0 mills specifically voted for general maintenance and operation and 11.8 mills voted for debt service previously voted as a continuing levy pledged for the retirement of existing bonded indebtedness. The surplus revenues produced each year by debt service millage may be used by the District for other school purposes. The total proposed school tax levy of 36.8 mills represents the same rate presently being collected.
